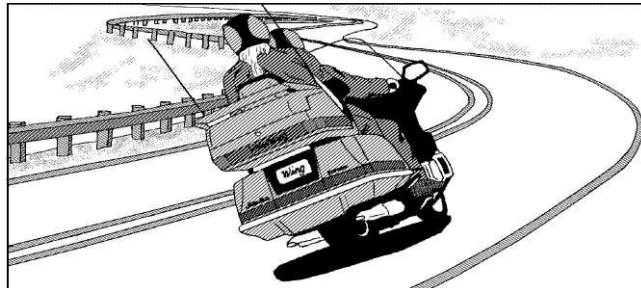

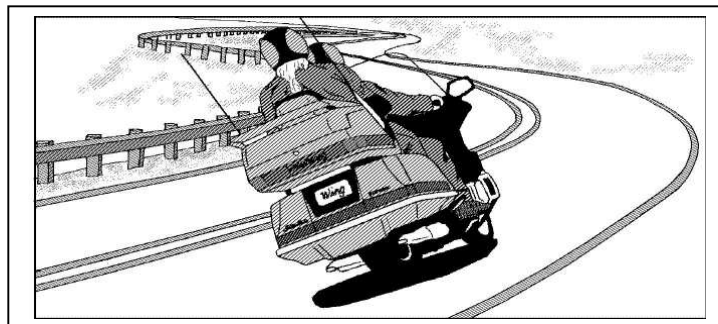
Chuck has submitted all the dinner requests; he will confirm with Jesse @ the Sportsman that everything is set for the afternoon.
